Rensselaer Mayor Michael Stammel approached the Rensselaer County Executive to have the County apply for the Restore NY Grant for Railroad Place Apartments LLC. Both applications are due by 3 PM, 10/11/2022. Input for these applications were given from this Agency, City of Rensselaer Mayor and Common Council, City of Rensselaer Planning Department, Rensselaer County Executive and Legislature, and legal counsel from both the City and County. As a result of combined action, up to 4 million in aggregate funding is being pursued to assist with projects.
